#### Sub: Mandatory transfer of Equity Shares of the Company to Investor Education and Protection Fund (IEPF) Account

Shareholders may note that both the unclaimed dividend and the shares transferred to IEPF including all the benefits accruing on such shares, if any can be claimed back by them from the IEPF Authority after following the procedure prescribed by the Rules (refer the IEPF website <http://iepf.gov.in/>) and no claim shall lie against the Company.

Shareholders are requested to claim the final dividend declared during the FY 2015-16 and onwards before the same is transferred to the IEPF. In case the Company does not receive any communication from the concerned shareholders on or before 4th September, 2023, the Company shall with a view to complying with the requirements set out in the Rules, transfer the shares to IEPF by the due date as per procedure stipulated in the Rules.
