Sub: Clarification on Outcome of Board Meeting held on 28th October, 2020

With reference to Email from NSE on 30th October, 2020 and in continuation to our letter dated 28th October, 2020 regarding outcome of the Board Meeting we would like to clarify that:

- 1. Existing Capacity Existing Installed Capacity of Methyl Amines is 48,000 and DMF is 30,000;
- 2. Existing Capacity Utilisation Existing Capacity utilisation is around 85-90% for Methyl Amines and 30% for DMF
- 3. Period within which the proposed capacity is to be added The Company is in process of finalising the detailed engineering plan. The timelines are therefore likely to be known in due course of time. However it is expected to begin in the FY 2021-2022 and completed during the Financial Year 2022 2023.
- 4. **Investment required –** Company is in the process of finalising the detailed engineering plan, the investment size is expected to be approximately upto Rs. 200cr.
- 5. Mode of financing Company will explore the financing of the project by way of a mix of Debt and internal accruals once the detailed Project report is prepared.
